- 1. I move that a new facility assessment be carried out for the Hebbville Elementary facility at Hebbville Academy, Pentz Elementary School, Petite Riviere Elementary School, and Newcombville Elementary to compare the viability of major renovations with new construction, with a recommendation to the Board by February 28, 2009. (This adds Newcombville to the consultant's recommendation.) CARRIED
- 2. I move that Big Tancook Island Elementary School be identified for school review and that a School Review Impact Assessment Report be completed by May 31, 2009, for consideration by the Board, as per the requirements of the provincial School Review Process. (*This delays the review by one full year.*) **CARRIED**
- 3. I move that Lunenburg Junior-Senior High School be identified for review, and that a School Review Impact Assessment Report be completed by May 31, 2008, with a specific focus on grades 10 to 12, and with the intent of re-configuring the school to become a Grade 6-9 school and that the senior high students attend Park View Education Centre. **CARRIED**
- 4. I move that Centre Consolidated School, Lunenburg Academy, and Lunenburg Junior-Senior High School grades 6 to 9 be identified for a review, and that a School Review Impact Assessment Report be completed by May 31, 2008, for consideration by the Board, as per the requirements of the provincial School Review Process, with the intent that a comprehensive study be carried out to weigh the advantages and disadvantages of constructing a new Grade P-9 school to replace Centre Consolidated School, Lunenburg Academy, Lunenburg Junior-Senior High School grades 6 to 9, and Riverport Elementary. (*This has been modified to include Riverport, in case Riverport does not close through the school review process.*) **CARRIED**
- 5. I move that the option of students remaining at Newcombville Elementary School for grade five, beginning in September 2008, be investigated immediately, and that a recommendation be presented to the Board for final decision at the April 2008 Board meeting. (*This recommendation will not require a full school review process.*)

- 6. I move that Greenfield Elementary School be identified for school review and that a School Review Impact Assessment Report be completed by May 31, 2009, for consideration by the Board, as per the requirements of the provincial School Review Process. (*This delays the review by one full year.*) **CARRIED**
- 7. I move that Milton Centennial School be identified for school review and that a School Review Impact Assessment Report be completed by May 31, 2008, for

consideration by the Board, as per the requirements of the provincial School Review Process. **CARRIED**

- 8. I move that Mill Village Consolidated School be identified for school review and that a School Review Impact Assessment Report be completed by May 31, 2008, for consideration by the Board, as per the requirements of the provincial School Review Process. **DEFEATED**
