Curriculum Guides

If teachers have not yet downloaded the curriculum documents or Learning Outcomes Frameworks, they can be found (not all) in various stages (final, draft, conceptual, ..) on the **EduPortal.**

The DoE are now housing all the curriculum guides/documents in a one-stop place called the **EduPortal**. Check this central place out at <u>http://edapps.ednet.ns.ca/eduportal</u> You will need your Employee Number as found on your payroll information to enter the site. Go to Resources and then Educator's Site to access the curriculum documents.

There may be old and new draft outcomes both on PowerSchool for subjects like Health P-9, Social Studies 5, etc. It is up to staff and principals to decide where they are in the implementation stage (usually a 3-year implementation for new curriculums). We

encourage teachers to use the newer outcomes whenever possible, especially if there are support resources available (i.e. Health P-9).

- Skilled Trades Learning gives students the chance to experience the skilled trades as a possible career option. Students work in an authentic learning environment using the same tools, equipment, and materials as professional tradespeople. As a result of Kids and Learning First, the province's new education plan, the number of schools offering Skilled Trades will double over the next four years. FHCS will be undergoing a renovation and will be offering Skilled Trades courses beginning in September 2013. - Kids & Learning First plan looks at doubling the number of Skilled Trades locations in our province in the near future and also offering a new skilled trades course, Manufacturing Trades, linked to shipbuilding (TBA).
- The Designated trades update (September 2012) has been sent out to our O2, Co-op, STEP and Skilled Trades teachers.

The following criteria must be met for schools to be able to offer a skilled trades program:

- The most productive Skilled Trades schools have a journeyperson teacher with a full Skilled Trades teaching load. This would mean that 6 or 7 Skilled Trades courses would be offered each year. With class sizes limited to 16 students, a steady demand of 93 to 112 Skilled Trades students (taking any of the offered Skilled Trades courses) would be necessary.
- The requirement of a certified Journeyperson is critical to success of students and the program. As well, students who successfully complete Skilled Trades courses taught by a certified journeyperson receive apprenticeship hours for the time that they were in class.
- Skilled Trades courses are to be delivered in a Skilled Trades Centre, approximately 2400 sq of space with high ceilings. Extensive renovations may be necessary.
- The culture of the school and commitment of the Principal must be strong in all our high schools that are prepared to offer Skilled Trades courses. The Culture of the School and Commitment of the Principal is strong in all our high schools in offering the Skilled Trades courses but further

discussion will be needed in meeting the guidelines set forth by the DoE in some of our interested schools.

• Technology Education courses (grades7-9, and grade 10-12 PSP Technology Education courses) in a Tech Lab setting are not to be replaced by the Skilled Trades courses but remain for the purposes of other learning opportunities and possible career choices for our students.

- John Drish orders all PPE for each Skilled Trades location. He usually guestimates the numbers. This equipment should be at your Skilled Trades Centre by the start of school or by the end of the 1st week. John needs to know what your inventory is after distribution first semester to the ST10 (ONLY) students. He has included vests to be used during classes which require them (ST10 and CT11). There may not be enough for each student so they will have to be shared among the students.
- John has also contacted Work Authority and asked them to not deliver any **safety boots** until the week of September 1,2014. He wants the class rosters to finalize before getting this done. Skilled Trades Centres are high priority for Work Authority and no school will wait an undue amount of time before the truck visits. Please let John know if you are having difficulties.

• The equipment in the Skilled Trades Centres (including all pneumatic equipment, jack stands, and the like) must undergo an <u>annual inspection</u> to determine fitness. John Drish has hired Greeno's Equipment Service Ltd, (902)798-7734, to conduct the inspection and has included \$1000 to cover the cost at each school. John Drish does not endorse any other provider but ask that you contact Greeno or someone similar to conduct the inspection reports in a place where this type of information can be readily found. The DoE will continue to provide adequate funding for the inspections but it is the school's responsibility to ensure that the inspections are done annually as this is a safety concern.
