- Term Teacher status is outlined in Article 22 in the NSTU Local Agreement.

Round 4 – All Remaining SSRCE Permanent and Term Positions (Job Fair)

- Permanent teachers are placed in this round. Remaining Term A and B teachers will participate in a Job Fair for remaining positions. Terms C and D teachers will be interviewed for remaining positions. Teachers hired in the “term early hire pool” can also apply in this round.
